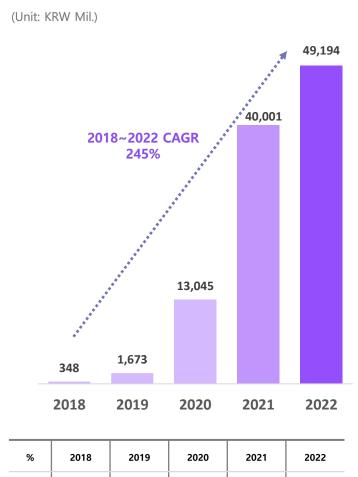

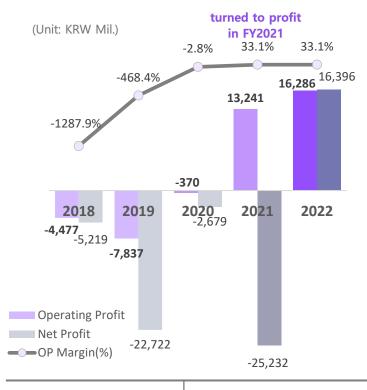

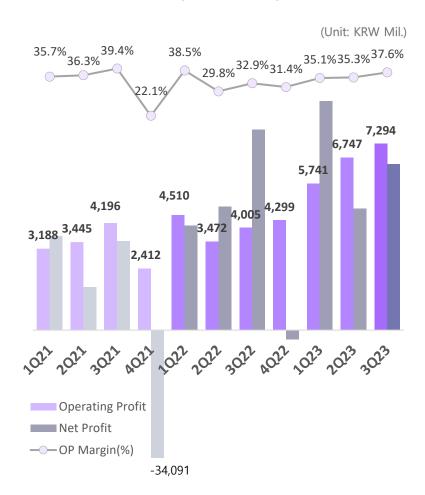

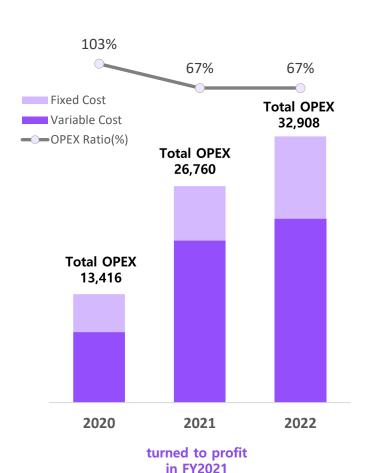

#### **Yearly OPEX Trend**

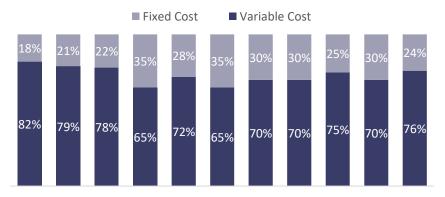

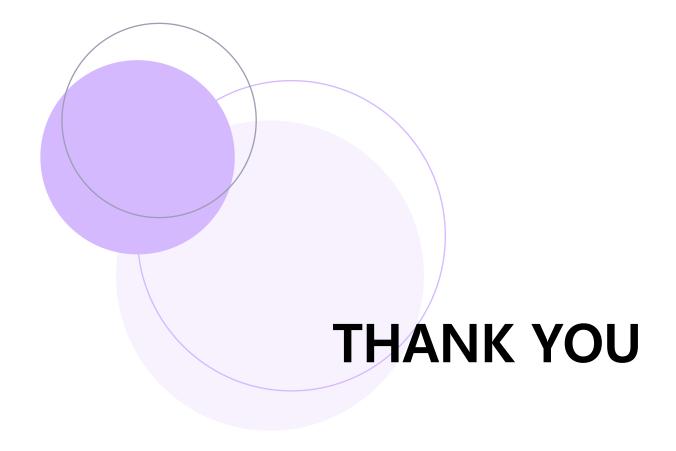
